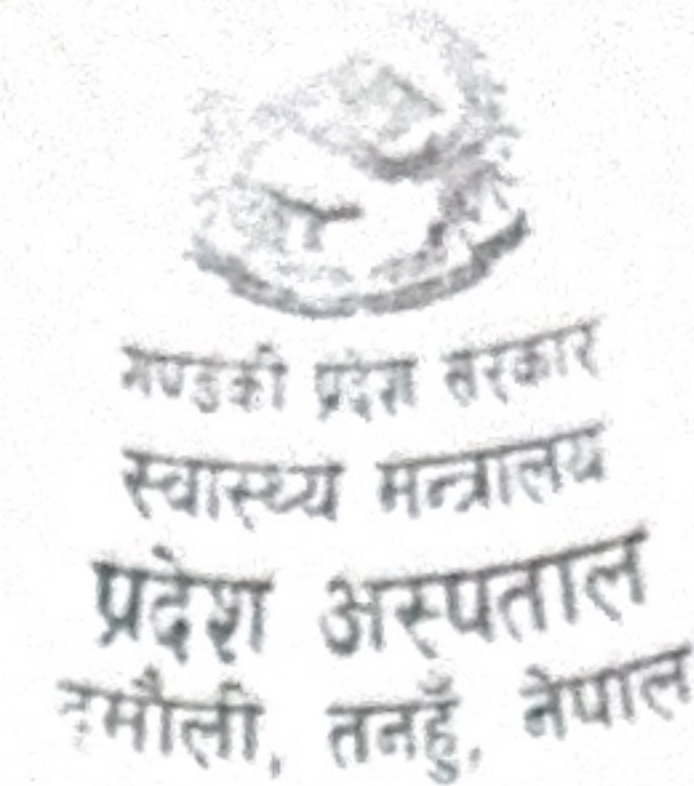

The absence of bidders representatives will not prevent the opening of the proposal. Bids must be valid for a period of 90 days from the date of bid opening and must be Submit Hard Copy, amounting to a minimum amount of bids mentioned below, which shall be valid for 7 days beyond the validity period of the bid.

7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.

8. The Employer reserves the right to accept or reject any or all the bids without assigning reason, whatsoever. Any intimidation, collusion and curtailing during bidding process shall be punishable by law.
